

**NEW AMSTERDAM & UFC TILE TAP OUT SWEEPSTAKES  
OFFICIAL RULES**

**This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

The New Amsterdam & UFC Tile Tap Out Sweepstakes (the "Sweepstakes") will commence at 12:00:00 AM Pacific Time ("PT") on January 1, 2026 ("Start Date") and end at 11:59:59 PM PT on December 31, 2026 ("End Date"). The period between the Start Date and End Date will be referred to as the "Sweepstakes Period". The Sweepstakes Period will be broken out into twelve (12) separate entry periods (each, an "Entry Period"), as set forth in the Entry Period Chart ("Chart") in Section 3 below. Entries submitted past the expiration of each Entry Period date will not be accepted.

1. **SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. Gallo Winery, 600 Yosemite Blvd., Modesto, CA 95354 ("Sponsor"), and is administered by Moosylvania, 7303 Marietta Ave, Maplewood, MO 63143 and Arrowhead Promotion & Fulfillment Co. Inc., 1105 SE 8<sup>th</sup> Street, Grand Rapids, MN 55744 (each an "Administrator"), for Sponsor's New Amsterdam Vodka brand ("Brand").
2. **ELIGIBILITY REQUIREMENTS.** The Sweepstakes is open to legal residents of the United States (excluding Utah) and the District of Columbia who are 21 years of age or older. VOID IN UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Directors, officers, employees, and agents of Sponsor, Administrator, Zuffa, LLC (dba UFC), and any retail licensees, authorized licensees, wholesale licensees, distributors, and each of their respective parent and/or sister companies, affiliates, subsidiaries, advertising and promotional agencies, and all other corporations, partnerships, or other legal entities or individuals associated with the development, administration, or fulfillment of this Sweepstakes, and the immediate families of such persons (defined as spouse, child, sibling, parent, son-in-law, daughter-in-law, grandparent, so-called "step" or "half" variations of any of the preceding individuals, and all descendants and each of their respective spouses, regardless of where they live), and those living in their same households, whether or not related, are ineligible to enter, win or collect prizes in the Sweepstakes. completed the foregoing, entrant will have earned one (1) entry (each a “QR Code Entry” and collectively the “QR Code Entries”) into the Sweepstakes. QR Code Entries must be received by 11:59:59 PM PT by each respective Entry Period End Date listed in the Chart below to be entered into that Entry Period. Any entry that is received after 11:59:59 PM PT on December 31, 2026 will be disqualified and that entry attempt will not be eligible for entry into the Sweepstakes.

- B. **Website:** To enter via the Website, visit [www.TileTapout.com](http://www.TileTapout.com) and follow the instructions to complete and submit the entry form during the Sweepstakes Period. Once entrant has completed the foregoing, entrant will have earned one (1) entry (each a “Website Entry” and collectively the “Website Entries”) into the Sweepstakes. Website Entries must be received by 11:59:59 PM PT by each respective Entry Period End Date listed in the Chart below to be entered into that Entry Period. Any entry that is received after 11:59:59 PM PT on December 31, 2026 will be disqualified and that entry attempt will not be eligible for entry into the Sweepstakes.

QR Code Entries and Website Entries may be referred to herein individually as an “Entry” or collectively as “Entries”. To be eligible, the Entry must be in English. Your Entry must be received within the Sweepstakes Period. **Limit:** Entrant may enter once per person/email address per Entry Periods 1 through 12 regardless of the method of entry. Entrant may have a maximum total of 1 entry per Entry Periods 1 through 11. All eligible entries received for Entry Periods 1 through 11 will automatically be entered into Entry Period 12. Entrant may have a maximum total of 12 entries in Entry Period 12. **5. Winner Notification:** Sponsor or Administrator will attempt to notify each potential winner (“Potential Winner”) via e-mail on or about the date described in the chart above. Potential Winner must respond within two (2) days of notification attempt. Failure to respond to notification as directed within the stated time will result in forfeiture of the prize. Awarding of any prize is subject to verification of Potential Winner’s eligibility and full compliance with these Official Rules. The ARV for each Second Place Prize in Entry Periods 1 through 11 is \$300.00. The total ARV of all the Second Place Prizes to be awarded during the Sweepstakes Period is \$26,400. Gift cards are subject to the terms, conditions and restrictions set by the issuer. Alcohol is not included as part of any prize. Second Place Prize will be sent to address provided by winner after winner is verified and returns the completed Affidavit and Release. No PO boxes permitted. Unclaimed or returned prizes will not be awarded. Sponsor and the Administrator are not responsible for any legal, or other restrictions on winner's use of the prize. The experience will include two (2) Floor tickets to UFC Event and two (2) tickets to the same-day UFC Post Octagon Tour scheduled to take place within six (6) months from the Entry Period 12 Winner Notification

date and one (1) commemorative event poster. The exact date, time, and location of the fight will be determined by the event organizer and communicated to the winner once confirmed. Sponsor is not responsible for scheduling, rescheduling, cancellation, or postponement of any event. Tickets awarded as a prize must be redeemed within 6 months of prize issuance. Winner is responsible for all travel, lodging, and other expenses not expressly included in the Grand Prize. The total ARV for the prize in Entry Period 12 is \$6,800. Tickets are subject to all ticket terms and conditions as well as all venue and UFC procedures, policies, protocols, including, without limitation, security and guest conduct, health and safety, and applicable bag policies. Neither Sponsor nor Zuffa, LLC (dba UFC) will be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any UFC Event or UFC Experience. Guest must complete a Travel Companion Affidavit and Liability Release Form and submit it to Sponsor or Administrator before the prize is awarded.
