

**Stratusphere Gin Basketball Merch Giveaway
Official Rules**

This Sweepstakes is intended for legal residents aged 21 or older of the United States, (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

The Stratusphere Gin Basketball Merch Giveaway (the “Sweepstakes”) will commence at 12:00:00 PM Eastern Time (“ET”) on August 3, 2026 (“Start Date”) and end at 11:59:59 PM ET on August 29, 2026 (“End Date”). The period between the Start Date and End Date will be referred to as the (“Sweepstakes Period”). The Sweepstakes Period will be broken out into four (4) separate entry periods (each, an “Entry Period”), as set forth in the Entry Period & Prize Chart (“Chart”) in Section 3 below. Entries submitted past the expiration of each Entry Period date will not be accepted.
