

RumChata Unusual Gift Sweepstakes Official Rules

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

RumChata Unusual Gift Sweepstakes (the "Sweepstakes") will commence at 10:00:00 AM Pacific Time ("PT") on November 3, 2022 ("Start Date") and end at 10:00:00 AM PT on December 18, 2022 ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period"). The Sweepstakes Period will be broken out into five (5) separate entry periods as set forth in Section 3 below (each, an "Entry Period"). Entries submitted past the expiration of each Entry Period date will not be accepted.
